## **Master's Update**

In May, the Sovereign Wealth Fund Institute (SWFI) embarked on an exciting partnership with the Guild of Investment Managers and Investment Managers' Charitable Trust to provide additional bursaries to young individuals, with the aim of improving diversity in the investment management industry.

A joint inaugural Charity Dinner was held at the Haberdashers' Hall to raise funds to support the Charitable Trust so it can help those without the necessary means acquire



the initial financial qualifications required for a career in investment management.

In the presence of Lakshmi Narayanan, founder of SWFI, Anthony Yadgaroff, Chair of the Charitable Trust, Henry Pollard, Master of the Guild and the Representative Lord Mayor of the City of London, Alderman and Past Master Robert Hughes-Penney, the well-attended event was a huge success, not least because it was addressed by the pivotal leader in global finance H.E. Dr. Nayef Falah Al-Hajraf, former Secretary General of the Gulf Cooperation Council and past Chairman of the Kuwait Investment Authority, the world's oldest sovereign wealth fund.
