Master's Update

Sovereign's Dinner

Without a doubt the key occasion was the **Sovereign's Dinner** on **18th October**

His Majesty The King arrived with Queen Camilla at Mansion House in the City of London to recognise the work of the City's civic institutions and Livery Companies, upholding the tradition of a new monarch's first visit to the Square Mile in their Coronation year, a tradition started in 1689 with King William III. The anointing canopy commissioned by the King was displayed and I had the good fortune to sit next to the designer Aidan Hart and some 10 feet away from Their Majesties. A magical evening!

In a powerful speech, The King described the UK as a 'community of communities', 'an island nation in which our shared values are the force which holds us together, reminding us that there is far, far more that unites us than divides us'. He urged people to step up and face the 'stark realities' of climate change and - against the backdrop of conflict in the Middle East - urged people to draw on the 'deep well of civility and tolerance, on which our political life and wider national conversation depend and allow the practice of all religious faiths. 'Such understanding, both at home and overseas, is never more vital than at times of international turmoil and heart-breaking loss of life,' he said.

As Their Majesties arrived, they took part in a traditional ceremony, the Presentation of the Pearl Sword. The relic, thought to have been given to the City of London by Queen Elizabeth I in 1571, has approximately 2,500 pearls on its scabbard. After receiving the sword from the Lord Mayor, the King returned it, signalling the authority of the Lord Mayor in the Square Mile when the King is not present. The ceremony was carried out by Queen Elizabeth II in 1953, the year of her Coronation, and in the years of her Silver and Golden Jubilees in 1977 and 2002.

In October

The next morning, I attended the **Boutique Managers breakfast** hosted by the Lord Mayor and attended by some 30 representatives of small fund management companies. My thanks to IIMI and especially our colleague Simon Pryke for the invitation. In November

The **Garden of Remembrance Service** took place in St Pauls Churchyard on Monday 6th November 2023, where some 115 livery companies and guilds paid their respects to the fallen at the annual service of Thanksgiving.

Per tradition, the Service was attended by the Lord Mayor and Sheriffs, as well as representatives of the Armed Services and other dignitaries.

I laid our cross on behalf of the Guild.



The Silent Ceremony

Attended the **Silent Ceremony**, where the new Lord Mayor is installed, and it is held in silence apart from his name being said in allegiance to the Sovereign.
